## Reservation confirmation

---

Banquet room reservations are confirmed once an event contract, invoice and deposit are completed. Room reservations are made in a first come first serve basis. Room prices fluctuate constantly.

## Deposit

---

A \$500 non-refundable deposit is required to hold date. Deposits are applied to the total charges. Balance is due 7 days prior to your event. In case of a cancellation a handling fee will be deducted and only a portion of your deposit may be refunded only 60 days prior to your event.

## Food & Beverage

---

A custom estimate will be provided based on menu selection. Swan-Court provides all food and beverages with the exception of ethnic hors d'oeuvres and cakes. when choosing two (2) entrees, both entrees will be priced at the higher priced item. All beverage needs MUST be provided by our restaurant/bar. If the client provides their own wine and champagne, there will be a corkage fee applied. all food is subject to 20% service fee and local tax. Final guest count is due 7 days prior to event. ONLY COUNT INCREASES may be made two days prior to event.

## Hours of events

---

Lunch Functions have a 3-hour time limit. Evening functions have a 5 hour event time limit, not to exceed 10:00pm plus 1 hr. strike. Event room may be accessed four hours prior to event start time. Exceeding event time limits are subject to a \$250 fee. Swan-Court reserves the right to terminate a function refusing to comply with contracted event time limits.

Prices are based on 2023 market rates. Room prices are subject to change\*

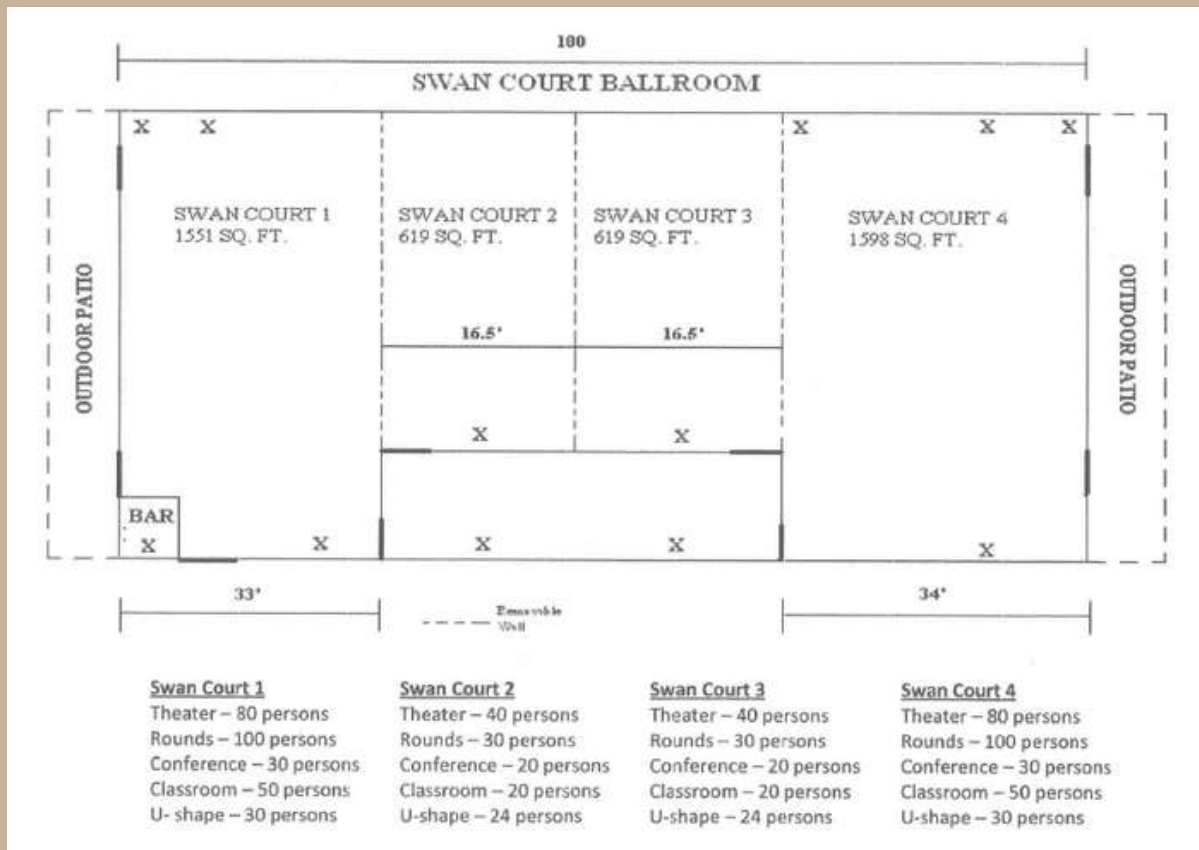
# Venu Diagram
