Please no crepe paper, rice, glitter, or confetti. A lift is available onsite for ceiling décor. Must be operated by Red Baron Arena staff.

## Food & Beverage

Food and beverage may be brought in only by a licensed caterer. Due to contractual rights, only Schwan's branded pizza and ice cream, as well as Coca-Cola brand beverages are allowed in the facility.

## Alcohol Policy

Alcohol can be brought in through an off-site liquor license. Liquor can also be brought in without a liquor license by the renter for parties with less than 500 people and not charging for drinks.

See city ordinance below.

Article II. Division 1. Section 6-21.

"Except as provided by law, no person may directly or indirectly, on any pretense or by any device, sell, barter, keep for sale, charge for possession, or otherwise dispose of alcoholic beverages as part of a retail commercial transaction without having obtained a license."
