



# Say I Do

## Agreement

This contract (the “Agreement”) is entered into between Rev. Colinda K. Abner (hereinafter referred to as the “Officiant”) as well as \_\_\_\_\_ and \_\_\_\_\_ (collectively referred to as the “Couple”) effective as of date signed.

### **WEDDING OFFICIANT SERVICES**

Officiant agrees to provide the wedding officiant services specified in the Services attached hereto and incorporated herein by reference (the “Services”). Couple shall provide officiant with all necessary information and access to the ceremony site to enable Officiant to perform the Services. The Officiant will wear a robe to perform the actual services. Officiant will be responsible for returning the marriage certificate to the county of record.

## **REHEARSAL (IF APPLICABLE)**

If Couple requests Officiant's attendance at a rehearsal, Couple agrees to provide Officiant with the date, time, and location of the rehearsal. Additional fees may apply for rehearsal attendance as outlined in Services attachment. Officiant will wear dress casual to the rehearsal.

## **PAYMENT AND ADDITIONAL FEES**

A non-refundable deposit of 50% is required to reserve the services for the specified date and time. This deposit is due at the time of signing this agreement. The remaining balance is due in full no later than 7 days prior to the scheduled wedding date. The Couple is responsible for any additional fees that may be charged, including but not limited to rehearsal sessions, extended script revisions, or travel requirements. If the wedding venue is further than 30 miles from the Officiant's home location, the Couple agrees to reimburse the Officiant for reasonable travel expenses, and if necessary, accommodation. This will be agreed upon in advance.

## **MISCELLANEOUS FEES**

Couple acknowledges that certain additional fees may apply if the scope of the Services changes, if additional services are required, or if any unforeseen expenses arise in connection with the performance of the Services. Such fees, if any, will be communicated to the Couple in writing, and Couple agrees to pay such fees in addition to the amounts set forth in the services attachment.

## **CHANGES**

Any changes to the Services, including ceremony date, time, or location must be requested in writing, by Couple and approved by Officiant at least 14 days prior to the Ceremony Date. If the changes result in additional costs, Couple agrees to pay such costs.

## **CANCELLATION OF SERVICES**

If the Couple decides to cancel the Services, written notice must be provided to the Officiant as soon as the decision is made. The non-refundable deposit paid upon signing this Contract is forfeited in the event of a cancellation by the Couple. If cancellation occurs within 7 days or less of the Ceremony Date, the Couple shall be responsible for payment of the full amount specified in Services attachment. If the Couple fails to provide the required license on the day of the ceremony, the Officiant will be unable to proceed with the marriage ceremony. However, the Officiant may conduct a symbolic ceremony for the Couple. The Couple acknowledges that a symbolic ceremony does not hold legal weight and will not result in a legally recognized marriage. The decision to proceed with a symbolic ceremony is entirely at the discretion of the Couple and the Officiant. The Officiant will provide a Sign and Go ceremony for the Couple within 30 days if a license is produced for an additional \$25.00 fee.

## **COUPLE RESPONSIBILITIES**

Couple shall ensure that the ceremony site is accessible and that any necessary permits or permissions required for the ceremony have been obtained. Couple shall also provide Officiant with accurate and complete information necessary for the successful performance of the ceremony, including, but not limited to, ceremony details, special requests, and any required personal information. Couple is also required to provide the marriage license prior to the ceremony.

## **LIABILITY**

In the unlikely event that the Officiant is unable to perform the services due to illness, injury, or other circumstances beyond their control, the Officiant will make every effort to secure a suitable replacement. If a replacement cannot be found, the Officiant will return any fees paid, including deposit.

## **OVERTIME FEES**

The Couple and all participants involved in the ceremony will make every effort to be punctual and adhere to the agreed-upon start time. However, a reasonable grace period of 30 minutes past the scheduled start time will be given to accommodate any unforeseen delays. If the ceremony is delayed beyond the provided grace period, which results in an extension of the Officiant's services, overtime fees may apply. These fees will be calculated based on a rate of \$100.00 an hour (billed in half hour increments).

## **CONFIDENTIALITY**

Both parties agree to hold in strict confidence and not disclose, directly or indirectly, to any third party any confidential information, including but not limited to, pricing, business plans, or personal information, that may be acquired during the term of this Agreement or in connection with the performance of the Services, except as required by law or with the prior written consent of the other party.

## **INDEMNIFICATION**

The Couple agrees to indemnify and hold harmless the Officiant from and against any and all claims, injuries, liabilities, damages, and costs, including reasonable attorney's fees, arising in connection with the Services, except in the cases of gross negligence or willful misconduct.

## **ENTIRE AGREEMENT**

This Agreement, together with the Services attachment, constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior and contemporaneous agreements, negotiations, and understandings, whether oral or written. This Agreement may only be amended in writing, signed by both parties.

**FORCE MAJEURE**

Neither party shall be held accountable for unforeseeable circumstances or events beyond their control, including acts of nature, government actions, war, epidemics, or other events hindering the contract’s performance. The affected party must promptly notify the other party and make reasonable efforts to mitigate the event’s effects.

\*\*\* Please note that a valid ID must be presented to the officiant prior to the ceremony from both parties. \*\*\*

*No modification, amendment, or alteration of this Agreement shall be binding unless it is made in writing and duly executed by both parties. By signing below, both parties acknowledge and agree to the terms and conditions stated in this Agreement.*

## Wed and Dash

\$100.00

*This packet consists of marriage in your car in my driveway with as many people as you can fit in your car. It includes the intent and pronouncement, signing of the documents and one picture with the officiant. Officiant will be responsible for returning the marriage certificate to the county of record.*

## Sign and Go

\$150.00

*This packet consists of traveling to location of your choice within 30 miles of my home location, intent, and pronouncement, signing of the documents, and one picture with the officiant. Officiant will be responsible for returning the marriage certificate to county of record. Travel over 30 miles will include travel fee. (1 or 2 guests,).*

## Basic Elopement

\$195.00

*This packet consists of traveling to location of your choice within 30 miles of my home location, a short prescript ceremony, signing of the documents, and one picture with the*

*officiant. Officiant will be responsible for returning the marriage certificate to county of record. Travel over 30 miles will include travel fee. (1 to 5 guests).*

*Extended Elopement* *\$225.00*

*This packet includes everything the Basic Elopement contains plus ring ceremony and one picture of the couple alone.*

*Pocket Size* *\$250.00*

*This packet consists of travel to location of your choice within 30 miles of my home location, a prescript ceremony including ring exchange, one picture with the officiant, one picture of the couple, and one picture of the couple with any attendants/family members. Officiant will be responsible for returning the marriage certificate to the county of record. Travel over 30 miles will include travel fee. (1-15 guests plus 2 attendants each).*

*Small/Vow Renewal* *\$300.00*

*This packet consists of travel to location of your choice within 30 miles of my home location, personalized ceremony including ring exchange, one picture with officiant, one picture of the couple, and one picture of couple with attendants/family members. Also included will be a keepsake, non-legal copy of a marriage certificate. Officiant will be responsible for returning marriage certificate to the county of record (Vow Renewal would have no marriage certificate to return). Travel over 30 miles will include travel fee. (1-30 guests plus 4 attendants each).*

# Add Ons



Rehearsal \$100.00

*A rehearsal may be added to the Small Vow Renewal Service. This will include up to 90 minutes within 30 miles of my home location. Travel over 30 miles will include travel fee.*

Overtime Fee \$100.00/hr.

*There is a \$100/hr. fee (billed in 30 minute increments) for a delay beyond the scheduled start time. There is a 30 minute grace period. This must be paid prior to marriage license being signed.*

Mileage \$1.00/mile

*Mileage fee is \$1.00 per mile over 30 miles from my home location.*
