
Package Pricing & Details

General Information

Payment

The Hall at Saint Peter's requires a deposit of \$750 to reserve the space for your reception. This money is non-refundable and is applied to your final balance. The remaining venue rental fee is due 90 days before the event date. The final headcount is due 14 days before the event and final payment due 7 days before the scheduled event. Payment may be made via cash, check, credit/debit, and money order.

Bar and Beverage

Outside beverages are not permitted. All events serving alcohol will be assessed a bartender/permit fee at \$200 and a security fee beginning at \$30 per hour for up to 50 guests and \$60 per hour for 50+ guests (Full Open Bar and Open Beer and Wine packages require 2 bartenders and an additional fee of \$27 per hour fee applies). The Hall has a two drink, per guest, per bar visit policy during any event with a purchased bar package. Alcoholic shots may be purchased and consumed at the bar during the event, prices vary by type/brand. When selecting an open bar package, the bar will close for 1 hour during dinner. If a cash bar is selected, bar service will remain open during dinner. Bar service concludes 30 minutes before your event ends. Last call will be announced 20 minutes prior.

Catering

The Hall at Saint Peter's permits an outside caterer be hired for your special day. However, outside beverages are not-permitted, even if provided by the catering service. Catering venues previously utilized by other couples are Martin's Supermarket, The Skillet, Linden Grill, and Monterrey Mexican Bar & Grill.

Service Charge

All packages are subject to 20% service charge and 7% Sales tax applies to food, bar and beverage packages.
