The Client is responsible for providing a safe and appropriate environment for the equipment, including adequate power supply and shelter in case of unfavorable weather conditions.

**Liability:**

The Vendor shall not be held responsible for any injuries, damages, or losses that occur to any person or property during the event, except in cases of gross negligence or willful misconduct.

The Client agrees to indemnify and hold the Vendor harmless from any claims arising out of the Client's negligence or misconduct.

**Cancellation Policy:**

If the Client cancels the event more than 7 days before the event date, the deposit will be fully refunded or the date of the booking can be changed, otherwise the deposit will be forfeited.

**Force Majeure:**

The Vendor shall not be liable for any failure to perform its obligations where such failure results from any cause beyond the party's reasonable control (e.g., weather conditions, health emergencies, power outages, infrastructure issues, shutdown by law enforcement).

Such failures obligate the Client to pay 50% of the hourly rate in addition to the compensation for the time spanned since the start of the Vendor's service.

**Miscellaneous:**

Hourly extensions of the Vendor's service are to be written under the "Event Details" clause.

This Contract represents the entire agreement between the parties and supersedes any previous written or oral agreement.
