RENTAL AGREEMENT

I **rent this property,** known as the River Edge Club, with the knowledge that I am responsible for any and all damage to the building, outside grounds or property's associated with the River Edge Club.

Associated properties are as listed: tables, chairs, bar, acoustic panels, light fixtures, and fire extinguishers. Kitchen equipment includes freezer, refrigerators, and faucets. Restroom property includes toilets, sinks, and fixtures.

Security/Damage deposit is \$400.00 dollars. I understand that I will get my deposit back if there are no damages to said property and keys are returned. I understand that I am responsible for any money over the \$400.00 dollar deposit is paid or charges will be filed at the Sheriff Department. Please allow up to 48 hours for deposit refund.

Cleaning/Set up Fee is \$300 dollars. This fee is to clean the building after your use. YOU ARE STILL RESPONSIBLE FOR PICKING UP YOUR TRASH, FOOD, DÉCOR, AND OTHER PERSONAL PROPERTY. The refrigerator and freezer must be turned in free of food or drinks. Please have trash bagged in placed in designated location.

Key Charge is \$200.00 dollars to change locks and it will come out of the security deposit, before returning the remaining amount of said monies.

Rental price - Event pricing is \$800 and a \$400.00 mandatory damage and clean up deposit.

Security Fee – Events that will include alcohol and/or that are scheduled past 8pm will require a security guard present. The security minimum rate is \$200 for 5 hours, and any additional security is \$40 per hour. All security costs will be charged to the renter.

Supplies provided: Loaded dual toilet paper dispenser, paper towels filled in dispensers. Cleaning supplies provided are dish soap, broom, mop and bucket, and bagged trash cans. A total of 9 45-gal trash bags will be provided. We recommend you bring additional trash bags.

Set Up Days – If the day before your event is not rented/scheduled, you will be allowed a 3-hour window to set up decoration and bring in other items for your event. Extensive décor plans may need to be discussed with the manager for approval. If you plan to use your own table or chairs a fee of \$200 is applied for handling.

Final Payments – Payment for building, set up/cleaning fee, and security (if applicable) are due 2 weeks before scheduled event.

Day of Event – You will be granted access to the building as early as 8am day of your event. Your event must end by Midnight 12AM.

- 9. No cooking or open flames allowed in the building. Only steam tables and chafing fuel cans allowed. Catered event preferably.
- 10.THERE WILL NOT BE ANY BICYCLES OR VEHICLES IN THIS BUILDING FOR ANY REASION.
- 11.<u>DO NOT PULL ANY VEHICLES ON THE FRONT SLAB</u>
 FOR ANY REASON. IT IS A PUBLIC SIDEWALK.
- 12. NO OUTSIDE TRASH OR ALCOHOL IS PERMITED OUTSIDE. KEEP ALL TRASH AND ALCOHOL INDOORS
